Tuition is an annual amount, paid monthly, based upon a 10-month schedule. Continued enrollment in Mountain Phoenix Community School is assured; however, it requires responsibility for timely payment of the entire School Year's Tuition and Fees. Payments are due on the 1st of each month. In cases where payment is 7 days past due, without making prior financial arrangements with the Business Office, your child's place in the program will be jeopardized. **Your non-refundable Materials Fee is due in full at Registration (August 3rd or 4th 2017).**

New and Returning Families: May 2019 tuition due at time of contract signing no later than June 1st, 2018 (or your spot may be given to another family)

August 2nd and 3rd~MPCS Registration for All Students: Materials Fees (in full) due as well as August 2018 tuition
September 1st – April 1st: Maintain appropriate tuition payment by 1st of each month - All Students

In signing this agreement, I _____ (print please) recognize that in the event my child leaves the program or changes his/her level of enrollment, my tuition obligation remains in accordance with the terms of this contract until MPCS has found another child to take his/her place. _____ (initial here) Thirty (30) days written notice is required to ensure that a replacement is arranged. All outstanding balances must be reconciled by June 1, 2018. **I understand that all fees and tuition reserve my student's place and are non-refundable.** _____ (initial here)
